

PRESIDENT'S REPORT

It was my great pleasure to serve as your MBA President during 2017/2018. It was challenging, eye opening and rewarding.

I made it my mandate this year to make sure that our members were aware of all of the benefits that the MBA and CBA have to offer. As always, it was a busy year at the MBA. We have continued to provide our members with quality substantive CPD events, Section meetings, networking opportunities, our Legal Directory and Day Planner, and our newsletter, *Headnotes* & *Footnotes*. As always, we put on our first-year law student mentorship events, the joint MBA/Royal Manitoba Theatre Centre Lawyer's Play, and Law Day, which is a celebration of the *Charter of Rights and Freedoms*. On top of all that, we had a very successful Mid-Winter Conference, our premiere event of the year, and we continue our advocacy efforts, speaking as the voice of the legal profession.

In addition to our usual activities, we had some exciting new successes this year. For the first time, Robson Hall Dean Jonathan Black-Branch arranged for CBA membership for all Robson Hall Law Students. We are incredibly grateful to Dean Black-Branch's support of the CBA and of the MBA. We understand that law students are the future of our profession, and we value their involvement tremendously. Related to this, we are also very pleased to be able to say that the MBA surpassed 1,500 members for the first time this year. The MBA was only one of two CBA branches to increase its membership numbers this year, which is something to be very proud of.

We were also very pleased to see the implementation of *The Queen's Counsel Act*, reinstating the Q.C. designation for Manitoba lawyers after a 17 year absence. The MBA has been asking the government to reinstate the designation for a number of years to ensure that exceptional Manitoba lawyers are recognized for their work and achievements. The MBA also hopes that this will provide an excellent opportunity to recognize lawyers who reflect the diversity of our profession.

The MBA also revised its By-Laws to align with the changes resulting from the new CBA governance model. Notably, we

reduced the size of our council from 36 members to 20 members (plus designated voting members), to take effect September 1, 2019.

As President, I was very fortunate to participate in so many things on behalf of the MBA. Some highlights included: attending the Public Interest Law Centre 35th anniversary conference; co-hosting this year's Bench and Bar Reception with Chief

Justice Joyal and his wife Joanne Préjet; attending the first ever CBA leadership forum in Ottawa; attending the retirement tribute dinner for the Right Honourable Beverley McLachlin in Vancouver; participating in two Masters Nominating Committees (resulting in the appointments of Master Jennifer Goldenberg and Master Robert Patterson); participating in a Judicial Nominating Committee (resulting in the appointment of Judge Theresa McDonald in The Pas, MB); and attending the Northern Bar Meeting (in Thompson, MB) and the Central Bar luncheon (in Portage la Prairie, MB).

I would like to thank all of the Executive Members of the MBA: Brad Regehr, Mark Toews, Peter Kingsley, Cynthia Lau and Carli Owens for your hard work and dedication. You were all an amazing support to the MBA and to me personally. It has been my privilege to serve in the position of Vice President of the MBA in 2017-2018. I have found the year to be very rewarding.

During the year, I had the opportunity to assist our President, Melissa Beaumont, wherever necessary, and help represent the MBA at a number of events and activities. In that capacity, I attended a number of meetings, Law School events and receptions, amongst other activities. These experiences will undoubtedly assist in preparing me for my upcoming year as President.

In my role as Vice President, I was responsible to provide oversight of Section activity. I have often said that Sections are the heartbeat of the CBA, and one of the most significant benefits of membership. Being involved in Sections provides our members with the opportunity to gain significant professional development and to be able to network and interact with other members that deal with common interests, challenges, and practice areas. During the course of this last year, our Sections have done a tremendous job in putting together professional development sessions, as well as other social activities. While I would like to take credit for the increase in membership, I must emphasize that our success on this front is attributable to a strong relationship between the MBA and Robson Hall built by Stacy Nagle and Dean Jonathan Black-Branch prior to my arrival on the Executive. It is wonderful to have Robson Hall students as members of the CBA.

In recognizing the importance of our relationship with our profession's future, we began the school year hosting a champagne reception with the Manitoba Law Student's Association (MLSA) at Robson Hall in order to introduce the first-year students to the MBA and during the course of the school year, provided support through the MBA/MLSA mentorship program. We also hosted a reception for the CPLED students and encouraged them to maintain their membership throughout their legal career.

I, along with the assistance of the entire Executive and MBA staff, reached out to lapsed members not only to encourage them to renew, but to determine how we can better address their needs or improve upon the services that the MBA offers. In addition, welcome letters were sent out to all new members that outlined the benefits of membership.

Our members continue to benefit from the many services and benefits that the MBA provides. This includes the Continuing Professional Development programs, primarily provided by our Sections, and the Mid-Winter Conference. The MBA also plays an important advocacy role in providing information to the Manitoba Government on numerous issues as it undertakes the reform of many departments that affect the practice of law and our membership.

I thank the MBA staff and fellow Executive Committee members for the support and encouragement I received during this year. I look forward to my second year as Director of Membership and serving the needs of our members.

SECRETARY / TREASURER'S REPORT

The audited financial statements for the fiscal year ended August 31, 2018 prepared by Jenkyns Smith, Chartered Professional Accountants can be found on pages 12 - 14. This is the sixth year that the financial statements have been prepared in accordance with Canadian Accounting Standards for Not-for-Profit Organizations (ASNFPO), which the MBA adopted effective September 1, 2012. Several items are worthy of note:

- As you know the MBA is a not for profit organization. As a result, we have attempted to control our cumulative surplus using small deficit budgets. Last year in response to comments of the CBA, we created a break even budget with our expenses and income evenly matched. However, primarily due to growth in branch membership numbers and the Mid-Winter revenue along with a decrease in our expenses, especially the administration expenses, the MBA realized an operating surplus of \$69,645.
- The aggregate of current assets and long term investments at year-end grew from \$386,275 to \$411,983. The long term investments were increased by \$103,073 as funds were invested in two new investments which will see 50% maturing every year. This grew our investments from \$121,486 to \$224,559. This obviously decreased our cash on hand from the high of \$230,214 to \$158,023, which is more in line with previous years. Our investments are now made up of roughly 60% equity funds and 40% GIC's. The equity funds have enjoyed a long term growth but have

been subject to market fluctuations over the past two years. This is why we have moved to fixed rate GIC's as a portion of our investments.

• Our aggregate revenue increased this year from \$620,461 in FYE 2017 to \$634,327 however our expenses remained almost the same, \$560,030 in FYE 2017 to \$560,177 in FYE 2018.

- The MBA will be changing the format of its budget for the next fiscal year. This is being done across the CBA to enable a consolidated budget to be prepared for the entire organization. This challenge was met ably by our staff.
- The MBA continues to be fiscally prudent and financially strong, putting it on a solid foundation for the realization of its short and long-term strategic goals. We will continue to monitor our income and expenses as the CBA moves through transformation to ensure that we continue this trend.
- While I am technically responsible for the budget, all the credit for the hard work and excellent care should go to our Executive Director, Stacy Nagle and her hard working team.



EXECUTIVE DIRECTOR'S REPORT.

In February 2016, the CBA approved a new strategic plan. The following is a list of the activities undertaken by the MBA in 2017/2018 under the five strategic pillars included in the strategic plan.

Develop Deep, Smart Member Intelligence

Deepen the knowledge and understanding of Members to better assess their aspirations, needs and satisfaction levels. Smarter data will lead to more relevant communications with Members and leading-edge offerings that equip them for success.

- The MBA Executive Committee members monitor monthly membership statistics.
- The MBA Executive Committee also monitors monthly website usage.

Deliver Distinct & Relevant Professional Development

Deliver professional development (PD) that includes both substantive education and skill development. Substantive education is important and will continue. Skills development offerings will be enhanced. Skill development is broadly defined and will be determined based on member needs, and includes cultural competence and skills and tools for self-improvement and personal success. An increased emphasis will be placed on delivering offerings both in English and French.

- The MBA, the University of Manitoba Faculty of Law and The Law Society of Manitoba featured the 2017 Isaac Pitblado Lectures on November 3, 2017. The conference examined the Future of Lawyering.
- The 2018 MBA Mid-Winter Conference was held on January 18 20, 2018. It featured 16 continuing professional development (CPD) sessions, which provided 39.5 hours of CPD, a bench and bar reception, an exhibitor trade show and the Awards luncheon. Approximately 500 people attended the conference.
- In 2017-2018, a total of 3,664 members attended 91 Section meetings (77 continuing professional development sessions including eight webinars; two Section business meetings and 12 Section networking events) that provided hours of 125 hours of CPD, many offered at no charge for members. Where possible, these meetings offer teleconferencing for members outside of Winnipeg. When available, written materials from Section meetings are posted behind the wall on the MBA web-site. Branch Section Chairs attended CBA National Section meetings. Travel rebates are provided to members outside of Winnipeg to attend MBA education programs in Winnipeg. Orientation workshops are also held for Section leaders.
- The MBA assisted the Western Manitoba Bar Association with the coordination of two CPD sessions in 2017-2018.
- The MBA promoted other CBA on-line and Law Society of Manitoba CPD programs.

Advocate on Behalf of the Profession

Focus on issues that shape the legal profession, improve the law, or advance the Rule of Law, including access to justice, through means

such as interventions and influencing the legislative process. Inform and solicit feedback from Members at all levels.

- Representatives from the MBA met with the Attorney General and Minister of Justice for Manitoba and the Justice Critic.
- The MBA Legislation and Law Stacy Nagle Reform Committee reviews legislation introduced and forwards it to Section representatives for their information and possible comments.
- Representatives of the MBA met with the Chiefs and Associate Chief Justices and Judges.
- Representatives from the MBA participated at Legal Aid Advisory Committee meetings.
- The MBA President, or their representative, spoke at Judicial swearing-in ceremonies.
- The MBA President, or their representative, participates on Provincial Court Judicial Nominating Selection Committees and Master's Nominating Committees. The MBA also has a representative on the Federal Judicial Advisory Committee.
- Responded to media inquiries.
- The MBA Family Law and Insolvency Law Sections along with the CBA Pension and Benefits Section provided submissions regarding Manitoba's review of *The Pension Benefits Act*.
- The CBA and MBA Construction Law Sections provided a submission to the Manitoba Law Reform Commission on *The Builders' Lien Act.*
- The MBA Construction Law Section submitted a letter discouraging the Provincial Government from enacting standalone prompt payment legislation.
- The MBA President spoke in favour of Bill 22 *The Queen's Counsel Act* at a legislative standing hearing.
- An open house for the public was hosted at the Winnipeg Law Courts Building in Winnipeg on April 15, 2018 for Law Day. The open house included: guided tours of the law courts, exhibits and displays, special sitting of citizenship court, mock trials presented by elementary and senior high students, high school student debates, question and answer sessions, and demonstrations by a victim services dog and a drug detection dog and their handlers. Approximately 1,200 people attended the open house. An open house was also held in Morden on April 27, 2018 that included a mock trial presentation and a question and answer session. Approximately 100 people attended that open house. Social media outlets Facebook and Twitter were used to promote 2018 Law Day activities, including some paid advertising.
- The MBA, the Office of the Public Trustee, and The Winnipeg Foundation presented "Will Week" on April 23 –

27, 2018 that provided free estate-planning seminars. Twenty-three presentations were held, attended by over 800 members of the public.

• The MBA participates on the Law Society of Manitoba's Forgivable Loan Program Committee and Access to Justice Committee and Sub-Committees.

Prepare the Profession for the Future

Building on a strong Futures foundation, further elevate CBA's leadership thinking to guide the profession toward a future that is in-step with emerging trends, needs and opportunities. See things before others see them, and inspire Members to lean into the future.

- The 2017 Isaac Pitblado Lectures examined the future of lawyering.
- Various Section meeting topics and articles contained in *Headnotes* & *Footnotes* focused on preparing the profession for the future.

Cultivate an Inclusive, Engaged Professional Community

Build a more powerful, inclusive, diverse and engaged professional community across Canada. Prioritize building membership among groups such as law students, articling students and young lawyers. Encourage Member exchange of knowledge, discourse on professional issues and peer-to-peer support. Facilitate interpersonal connections in person and, importantly, online.

- The mentorship program matched 97 law students and lawyers and held two networking events.
- The MBA hosted a reception for first year law students at the beginning of orientation week at the Faculty of Law, spoke to CPLED students during the first week of classes, hosted a reception for CPLED students, sponsored an "Exam Cram" at the Faculty of Law and spoke at the Call to the Bar ceremony.
- The contributions of the legal profession were recognized through Awards and a "What's Happening" column in *Headnotes* & *Footnotes*. The MBA also provides a financial prize (Solomon Greenberg Prize in Advocacy) for the first and second place students in the Robson Hall moot court competition.
- The MBA/RMTC joint production of *Witness for the Prosecution* was held on May 9 12, 2018. To date, CBA members have raised over \$1 million for RMTC.
- Various networking events were held throughout the year.
- A President's Reception was held to introduce the 2017-2018 MBA Executive Committee and Council members.
- MBA has a membership with Kids & Company Daycare. MBA members are guaranteed a full-time or part-time child care spot within six months.
- The MBA provided funding to a law firm, outside of Winnipeg, to hire a summer law student as part of our

contribution to The Law Society of Manitoba's Forgivable Loan program.

- Members of the MBA Executive attended regional bar meetings.
- Various membership recruitment and retention activities were held in 2017-2018.
- Weekly decision packages were distributed to subscribers. As decisions are now posted within 24 hours on CanLII.org, the MBA stopped providing this service as of August 31, 2018.
- Ten editions of *Headnotes* & *Footnotes* were prepared and distributed. Some members continue to receive the newsletter via a link to a pdf version or an on-line magazine format on the MBA web-site instead of a paper copy.
- Approximately 875 copies of the 2018 Legal Directory and 800 copies of the Legal Directory and Dayplanner were sold.
- On average www.cba-mb.ca has over 1,000 visitors each month.

Organizational Infrastructure

- I participated on bi-weekly video conference meetings of the CBA Management Team.
- I Co-Chair a team of CBA staff from across the country who are looking at how global/universal professional development programs can be developed and shared to enhance service to members.
- Council and Executive Committee orientation sessions were held.
- The MBA twitter account (@MBBarAssn) has tweeted and retweeted out 647 tweets since we went live in January 2017. We have 331 followers and have had 1,488 "engagements", which includes retweets, likes, and link clicks, of the 240 tweets that the MBA has composed.
- The MBA French Speaking Lawyers' Section changed its name to MBA French Speaking Common Law Members Section to align with the CBA Section name.
- Thank you letters were sent to MBA volunteers.
- All MBA staff receive yearly written evaluations.
- Staff is encouraged to take professional development.
- An audit was conducted on October 16, 2018 and no concerns were identified.

Thank you to all the volunteers who give so much of their time, knowledge and expertise to support the work of the MBA. Finally, I would also like to thank and acknowledge the hard work of the 2017/2018 MBA staff: Chelsey Tait, Melissa Tannahill, Kara Moore, Andrea Smorang and Tamara Edkins. Without their dedication and commitment, the MBA would not be able to provide the quality services to our members.



ADVOCACY AND PUBLIC RELATIONS

During the second year of my two-year term as Director of Advocacy and Public Relations, I had the privilege of being a participant and observer in many of the activities and initiatives of the Manitoba Bar Association (MBA). The membership itself is comprised of lawyers, law students, articling students, members of the judiciary and law professors in Manitoba - a testament to the commitment and contributions of the profession towards a strong voice.

As Director of Advocacy and Public Relations, I have been responsible for activities and initiatives of the Branch relating to advocacy, legislation and law reform and public relations, including promoting communication of these efforts within the Province.

In this role:

- I participated in Access to Justice Initiatives as MBA Representative, including the Access to Justice Steering Committee and Stakeholders Committee.
- I was your MBA Representative on the Lawyer's Play Committee. This year marked the 26th Royal Manitoba Theatre Centre (MTC)/MBA Lawyer's Play, *Witness for the Prosecution.* To date, we have raised more than \$1 million dollars for the programs and productions of the Royal MTC due to this outstanding collaborative effort. It could not be accomplished without the generous donation of time and effort by our talented members.
- Throughout the year, the MBA website was frequently visited by its members, the legal community, and the public. Usage statistics were steady, with an observed

growth during the months leading to the January Mid-Winter Conference. I was involved in the selection process for the annual MBA Recognition Awards and participated in the MBA Awards Luncheon.

In my opinion, this publication represents a huge time savings for those of us who are interested in, but cannot delve into, different areas of practice.

Much appreciation to the MBA's Legislation and Law Reform Committee, chaired by Melanie Bueckert. The committee does excellent work in reviewing provincial legislation and ensuring that the MBA and specific sections are alerted to relevant upcoming and new legislation.

PAST PRESIDENT'S REPORT

It was a pleasure to serve this past year as the MBA Past President. I was able to participate and contribute to a variety of meetings and events on behalf of the MBA throughout the year. It started when I was a "pinch hitter" for President Melissa Beaumont in September and attended the Western Bar Association meetings in her stead. I was able to address the Benchers of The Law Society of Manitoba about the changes to the Canadian Bar Association, which had been adopted the month before. These changes were the culmination of the CBA Re-Think project which I had the honour of working on while MBA President.

I participated in the CBA Virtual Hub in Winnipeg for the CBA Annual General Meeting in February. I attended the Law Society of Manitoba's 50-year dinner and the MBA Mid-Winter, as well as chairing the MBA Past President's Dinner where a recommendation regarding the recipient of the Distinguished Service Award was made. I also attended meetings with the Attorney-General and Minister of Justice for Manitoba and the Justice Critic, and a working dinner with the Chiefs and Associate Chief Justices and Judges of Manitoba. It is hard to believe that my time on the MBA Executive has come to an end. However, that does not mean that you will not hear from me – I still will continue to participate in MBA Executive and Council meetings as the CBA Board representative from Manitoba. I am proud to have been acclaimed to the CBA Board for the 2018-19 and 2019-20 years and look

forward to serving the Association in that role.

It has been an honour to represent you as Past President and I am so very grateful for having been given the opportunity to do so. I want to thank all of my colleagues on the MBA Executive and MBA Council for all their work and contributions. I also want to thank our top-notch MBA staff members. They make the MBA the success it is today. In particular, I want to thank Stacy Nagle, Executive Director of the MBA. Her professionalism, insight, advice and hard work cannot be taken for granted and make the Executive function so well.

CBA BOARD REPRESENTATIVE REPORT

The 2017-2018, the CBA Board of Directors met eight times over the course of the year.

One of the most prominent features of the new governance structure resulting from the CBA Re-Think was a significantly smaller National Board of Directors – 14 members instead of the previous 26. The Board is now comprised of one person from each province and territory, plus the President and the Chief Executive Officer (who is ex officio).

The 2017-2018 Board was the smallest in recent memory and was, without a doubt, the most diverse in the 122-year history of the CBA. Further, the new smaller Board format allowed for more in-depth and effective discussions of agenda items, with a variety of perspectives being put forward for consideration.

To ensure that some measure of continuity and "corporate memory" would be available to the (mostly new) Board members, the Re-Think Implementation Team decided that the CBA Past President (René Basque, Q.C.) would sit as the New Brunswick representative, and that the CBA National Treasurer / Chair of the Finance Committee (me) would sit as the Manitoba representative. Kerry Simmonds, Q.C. of Victoria, BC was already scheduled to assume the role of President, and that she did. All three of us undertook not to run for re-election.

Board activities over the year were heavily focused on implementation of the Re-Think recommendations and, in particular, operationalizing the new governance structure. These included:

- establishing key performance indicators for the Board, based on the CBA strategic priorities;
- reviewing the results of the CBA 2.0 Membership Programs, Products, and Services (MPPS) review findings;
- discussing and approving the Q2-Q4 budget for 2017-2018, and the budget for 2018-2019;
- tabling the final report of the Futures Committee (which provided a great foundation on which the new permanent Futures subcommittee can build);
- reviewing and discussing regular reports from each of the four new Board Committees (Governance and Equality, Policy, Finance, and Audit). In this regard:
 - Governance and Equality was kept busy with election planning, Board evaluations, and moving the equality and diversity mandate forward;
 - Finance spent a considerable amount of its time finalizing the Q2-Q4 budget, conducting the dues feasibility assessment mandated by the previous Board, preparing the 2018-2019 National Budget, and monitoring the ongoing financial health of the organization;
 - Policy made numerous submissions to the federal government on behalf of various National Sections, and brought forward several proposals for CBA intervention in cases before the Federal Court of Appeal and the Supreme Court of Canada; and,

- Audit focused its energies on the development of both external and internal audit processes;
- reviewing the diverse ways in which each Director managed his or her ongoing liaison with their respective jurisdiction (Branch / Canadian Corporate Counsel Association), with a view to ensuring consistency and transparency;
- reviewing and approving the recommendations of the Funding Formulae Task Force;
 - reviewing and approving several new and revised financial policies as recommended by the Finance Committee;
 - discussing and approving a proposed new Section Budget Process necessitated by the abolition of the National Sections Council and, in particular, its Budget Subcommittee;
 - establishing a Task Force to develop a CBA response to the Truth and Reconciliation Commission Calls to Action;
 - determining that Board Pre-Read materials would be shared with Branch Presidents and the Chair of the CCCA, and that Board minutes, once approved, would be posted to the "members only" section of the CBA website;
 - reviewing the recommendations of the International Initiatives Task Force; and,
 - establishing Board priorities for the balance of the term, and establishing financial priorities for the preparation of the 2018-2019 National Budget.

I am delighted to announce that in December, 2017, Ms Vivene Salmon (Toronto) was acclaimed as Vice President of the CBA for 2018-2019. She will ssume the presidency effective September 1, 2019.

Ms Salmon will be the first person of colour to hold the office of CBA President. She will also be only the second in-house counsel (and the first female) to fulfill the role.

During her first year on the CBA Board of Directors, Ms Salmon became known for her insightful, thoughtful, and respectful contributions to the discussions around the Board table. The CBA will most certainly be in good hands with her at the helm.

I am especially delighted to report that Mr. Bradley Regehr (Maurice Law) was acclaimed as the Manitoba member of CBA Board of Directors for a two-year term commencing September 1, 2018. This will be his second stint on the National Board, having served as a CBA Director in both 2015-2016 and 2016-2017. Brad is a dedicated volunteer who brings a wealth of valuable experience to his new role.

It was an honour and a privilege to serve as your representative on the CBA Board, and I am grateful for having been given this tremendous opportunity.

NOTES TO FINANCIAL STATEMENTS

Year Ended August 31, 2018

1. PURPOSE OF THE ORGANIZATION

The Manitoba Bar Association, a branch of the Canadian Bar Association, is a non-profit organization dedicated to enhancing the economic, professional and social interests and well-being of its members throughout the province of Manitoba. The Manitoba Bar Association represents approximately 1,500 members of Manitoba's legal profession, including: lawyers, judges, law students and law professors.

SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

2.

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO).

Fund Accounting

The Association follows the restricted fund method of accounting. Revenue and expenses related to program delivery and administration are reported in the General Fund, on an accrual basis. Purchases, sales and amortization of capital assets are reported in the Capital Fund.

Capital assets

Capital assets are stated at cost less accumulated amortization. Capital assets are amortized over their estimated useful lives at the following rates and methods:

Computer equipment	3 years	straight-line method
Furniture and fixtures	5 years	straight-line method

The Association regularly reviews its capital assets to eliminate obsolete items.

Investments

Investments are classified as held for trading and are recorded at market value.

Revenue Recognition

Restricted contributions related to general operations are recognized as revenue of the General Fund in the year in which the related expenses are incurred. All other restricted contributions are recognized as revenue of the appropriate restricted fund.

Unrestricted contributions are recognized as revenue of the General Fund in the year received or receivable if the amount to be received can be reasonably assured. Investment income is recognized as revenue of the General Fund when earned.

Fees and other income are recognized as revenue of the General Fund when the events are held and or services or products are provided.

Deferred revenue

Deferred revenue reported in the General Fund relates to revenue collected for the legal directory which will not be issued until the subsequent year.

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

Financial Instruments

Fair Value - Fair value is the amount that would be agreed upon in an arm's length transaction between knowledgeable willing parties who are under no compulsion to act. Fair value is an estimate, which is significantly affected by the assumptions and methods used in its determination. Further, estimation of fair value involves the use of subjective judgments and uncertainty. Fair value should not be interpreted as an amount which could be realized in immediate settlement of the instruments. With the exception of investments, management has estimated that the fair value of all financial instruments approximate their cost, as there is no active market for the assets and liabilities of the association that are financial instruments. The fair value of investments is based on the quoted market values.

6. FINANCIAL INSTRUMENTS

The association is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the association's risk exposure and concentration as of August 31, 2018.

Credit risk

Credit risk arises from the potential that a counter party will fail to perform its obligations. The association is exposed to credit risk from customers. In order to reduce its credit risk, the association reviews a new customer's credit history before extending credit and conducts regular reviews of its existing customers' credit performance. An allowance for doubtful accounts is established based upon factors surrounding the credit risk of specific accounts, historical trends and other information. The association has a significant number of customers which minimizes concentration of credit risk.

Liquidity risk

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The association is exposed to this risk mainly in respect of its receipt of funds from its customers and other related sources, long-term debt, obligations under capital leases, contributions to the pension plan, and accounts payable.

6. COMMITMENTS

On August 1, 2012 the Association entered into a 84 month lease for its office, terminating on July 31, 2019. Annual Base rent is as follows each rental period August 1 to July 31, \$13,635.00 (2013), \$14,392.50 (2014), \$15,150.00 (2015), \$15,907.50 (2016), \$16,665.00 (2017), \$18,180.00 (2018), and \$18,937.50 (2019) plus common area costs.
