PRESIDENT'S REPORT

Je profite de cette occasion afin d'exprimer ma gratitude pour tout l'appui que j'ai reçu au cours de l'année. Notre association provinciale continue d'être vibrante. Due in large part to you, the members, together with the support of our outstanding administrative staff, the MBA continues to provide top quality continuing education seminars and meetings and continues to be ever vigilant on issues of concern to you.

At a National level, we were again very well represented on CBA Standing Committees and Special Committees. We had representatives on 10 CBA Standing

Committees. We also had 23 of our members who held Executive positions on National Sections and Conferences. In addition, we had representatives on the CBA companies - Canadian Bar Insurance Association and Canadian Bar Financial Services Corp. Finally, Wayne Onchelenko has been acclaimed as Treasurer of the CBA and Guy Joubert was the 2nd Vice-President in 2006/2007. I can proudly say that we do more than our fair share at the National level.

This year the CBA adopted a strategic plan and Branches, including ours, adapted their strategic plans to mesh with the National one. We approved an exciting initiative; the hiring of an additional staff whose primary role will be to enhance services to members. This includes assistance to the branch Sections in organizing regular meetings with substantive CLE components. You, the members, continue to tell us in surveys that this is an important aspect of the services that your Association provides.

The Association is proud of the open lines of communication that it has with the Chief and Associate Chief Judges and Justices. This exchange allows us to improve the administration of justice by dealing with any issues in a proactive way.

This year, we also continued our regular meetings with the Minister of Justice and Attorney General for Manitoba and with the Justice Critic. Having regular meetings allows us to work with legislative representatives on various initiatives and legislative reform. The long awaited announcement of the construction of a new women's correctional centre to replace the dungeon at Portage La Prairie and the legislation enacted to exempt RRSP's from seizure are examples of success achieved through the efforts of many, including the MBA. We also promptly dealt with and clarified issues of concern such as media quotes of the Justice Critic to the effect that judges were out of touch with the public.

Nous sommes là à la rentrée des classes, pour la journée de carrière, pour les tribunaux écoles et pour les activités de mentorat. In addition, we continue to monitor the articling match process. Other issues include student loans and the rising cost of tuition. I also attended various other law school functions including an open forum at the law school with the then Federal Justice Minister, The Honourable Vic Toews. The tampering of the Federal Justice Selection Committee by adding law enforcement representatives and the cancellation of the Court Challenges Program were just some of the issues raised on your behalf.

This year the MBA had an active Legislation and Law Reform Committee, which tracked and commented on various Bills. We were also proactive in seeking comments from Universal membership law firms and MBA Section leaders on issues which were of concern to them.

My year as President was marked by an unusually high number of judicial appointments both at the Provincial Court as well as at the Superior Courts. The composition of about a quarter of the Provincial Court changed. One position was added to enhance service in Thompson. La Cour d'appel et la Cour de Banc de la Reine ont vu l'addition de juges bilingues.

Practicing law is not all about work. The annual charity golf tournament and curling bonspiel were successes as was the participation in the activities organized by the Central, Western and Northern Bars. On the issue of rural representation, we were fortunate to have one of our Council meetings in Dauphin, Manitoba. This allowed Council to visit the antiquated Dauphin Court house and see and better understand all of the issues faced by victims, the public, staff, lawyers and judges.

Finally, the MBA, as the voice of the profession, undertakes various activities for the benefit of the public and the administration of justice. Our support of MTC through the annual fundraising play has raised over \$750,000 to date and the resounding success of Law Day activities both in Winnipeg and Brandon are clearly appreciated and recognized.

VICE-PRESIDENT'S REPORT

From August 2006 until February 2007, Barry Effler was Vice-President of the MBA. Following Mr. Effler's resignation from the Executive in February 2007, I took on that role until my term ended in August 2007. The Vice-President is the member of Executive primarily responsible for Section activities. Sections and CLE programming are seen by most MBA members as integral parts of the Association.

In 2006/2007, the number of Section

meetings and the attendance at Section meetings decreased fairly significantly as compared to the previous few years. To address the decline, the MBA has hired Melissa Tannahill as the new Section/CLE coordinator. Ms Tannahill is scheduled to start work in November 2007.

In an effort to be more accessible to our non-Winnipeg members, in May 2007, we held a second video link CLE in the area of Family Law. Unfortunately, due some technical issues that were not within our control,

the CLE could not proceed. However, the MBA plans to continue with video link CLEs in the future.

Mr. Effler attended planning meetings for the MBA Mid-Winter meeting, and served on the Topic Selection Committee for the 2007 Pitblado Lectures.

On April 19, 2007, MBA Council approved the establishment of a branch Law Practice Management Section. The Section will focus on the business of the practice of law, including: organizational structure for law firms and law departments; recruitment and retention of legal talent; talent management and professional development, knowledge management, marketing of legal services, pricing of legal services, e-lawyering, multi-disciplinary and multi-jurisdictional practice of law; relationships between law firms and their clients; compensation systems for partners, associates, and in house counsel; ethics and professionalism in the delivery of legal services.

As Vice-President, I attended the CBA National Administrative Law conference in Winnipeg, chaired by MBA Council member, Robert Dawson.

As Vice-President, Mr. Effler or I attended meetings with the Attorney General of Manitoba and with the judiciary and participated in the Section Leaders Orientation Workshop.



My two-year term as MBA Membership/Member Services Chair ended in August 2007. For the last year of that term I also served as Chair of the CBA Membership Committee. During that two-year period, the CBA hired a full-time membership and marketing director and began aggressively working towards the goal of achieving 90% market penetration as mandated by the CBA Strategic Plan. For me, participating in this progressive and

potentially radical endeavour has been an exceptionally rewarding experience.

Manitoba Membership Statistics

As of August 28, 2007, Manitoba had 1,238 members (1,219 paid members), an increase of 1.3% from one year earlier.

Lawyers

The MBA secured the continuation of the provincial Crown's pilot project through which provincial Crown attorneys have half of their membership fees paid by their employer.

In April and May 2007, we had "Bring a Buddy" months during which MBA members were encouraged to bring out their non-member colleagues to Section meetings and other MBA events. Follow-up letters were sent to all "Buddy" lawyers who attended an MBA meeting or event during that month.

A one-page "cheat sheet" highlighting the benefits of membership was prepared and distributed at the December 2006 Council meeting. The list of "Preferred Suppliers" continues to be developed.

"Welcome letters" continue to be sent to new MBA members and follow-up phone calls were made to lapsed members.

Students/CPLED

Specifically for students, the MBA continued with its very popular lawyer/student mentorship program. Approximately 75 law students

were "matched" with 75 MBA lawyer members. A wine and cheese networking opportunity took place at Thompson Dorfman Sweatman LLP in November 2006 and a casual night of bowling at Academy Lanes was held in February 2007. Thanks go to Charlene Caron and her Committee who coordinated the 2006/2007 Mentorship program. In addition, members of the MBA Executive

CBA National

MEMBERSHIP/MEMBER SERVICES REPORT

I attended the meetings of the CBA National Membership Committee in October 2006, February 2007 in Mont-Tremblant and August 2007 in Calgary. National membership initiatives include:

- The completion of the segmentation survey by the time of the Calgary CLC in August 2007. Analysis of the survey results is ongoing. The 90% market penetration rate goal may be unrealistic.
- Personal meetings with universal firms and developing benefits to encourage firm universality.
- Review and continued development of a national advertising campaign aimed at boosting the image of lawyers in the eyes of the public.
- The continuation of the 5 year pilot project for free membership to Ontario law students with ongoing monitoring of its success in retaining students as paying members once they leave law school.
- Approval of a reduced fee rate for retired members.
- The extension of preferred rates to non-CBA member lawyers through TD Meloche Monnex for home and auto insurance.

SECRETARY / TREASURER'S REPORT

I have been delighted to serve as the Association's Secretary-Treasurer for the last 3 years. During that time, I can unreservedly report that in my opinion, the MBA - and its finances specifically - are very well maintained by the staff at the MBA and in particular, our Executive Director, Stacy Nagle. I am therefore pleased to provide with this report, the audited Financial Statements for the fiscal year ended August 31st 2007,

prepared by Dean R. Jenkyns, Chartered Accountant Inc.

Our investments are at \$323,824 providing a solid base of protection for our organization. In my opinion, with the addition of another part-time staff person to deal with Section growth and member services, a significant lease agreement (which had been put off for some time) and an aggressive plan to enhance member services including a number of longer-term initiatives, I suspect that although we shall be able to maintain those investments, we will not expect to see the kind of surpluses we have seen in recent years. However this is a positive development because as a not-for-profit organization, we ought not to be building too large an asset base. This year, our membership fees with related levies and rebates increased just under \$12,000, our investment income, \$3,000 which more or less accords with an overall increase of revenue over the previous year of about \$15,000, a total figure of \$416,440. On the other hand, our expenditures overall decreased by some \$14,000, a total figure of \$391,481. In part, we reduced Council activity costs and public relations while increased Member services and administration costs. The overall excess of revenue over expenses was some \$28,463.

The Association's fiscal situation remains in great shape. I do want to congratulate Stacy Nagle and her staff for the great fiscal processes and management, the Executive and Council for their collective wisdom. I am quite sure that Ms Karen Wittman, who assumes the role as Secretary/Treasurer for the year 2007-2008, will find her duties as rewarding as I did.



ADVOCACY AND PUBLIC RELATIONS REPORT

It has been my great pleasure to hold the position of Director of Advocacy and Public Relations for the year 2006-2007 previously known as the Communication Chair.

Headnotes & Footnotes

The Director of Advocacy and Public Relations is tasked with responsibility of reviewing *Headnotes & Footnotes* on a monthly basis. This is the end

result of the enormous contribution by our Executive Director Stacy Nagle to have each edition formatted and all contributions vetted for publication. In this past year we initiated a new feature "Universal Firm Spotlight". We have continued to feature Dean Scaletta's very popular column "What's Happening?".

Legislation and Law Reform Committee

This was the first year for this very important Committee to be up and running with a mandate from Council. Ken Mandzuik and his committee members, Michelle Gallant and Grant Stefanson circulated notices to relevant Sections for their input and maintained a watchful eye on legislation as it was introduced in the legislature.

MBA Website

Our website continues to receive many hits and be an important avenue for members to access us and the services we provide.

MTC/MBA Production

This year's production of A Midsummer Night's Dream was our primary community fund raiser. The MTC Production has been very successful each year and provides a positive image of lawyers in our community. The production raised over \$91,000 for MTC, bringing the total amount to \$750,000 raised to date.

MBA Legal Directory & Dayplanner

This is an essential tool on every lawyer's desk. The sales of the directory continue to rise year after year and this year was no exception with over 1,925 copies of the directory sold.

Bar Bonspiel

Eighteen teams participated in this year's event that was held on Friday, March 9, 2007 at the Granite Curling Cub. Kerry UnRuh and Dana Kochan from Deeley Fabbri Law Corporation organized this event.

Charity Golf Tournament

The 2007 MBA charity golf tournament was held on May 28, 2007 at Elmhurst Golf & Country Club. Approximately 50 golfers participated in this event. Thanks go to Bill Malcolm and Ron Simenik who organized the tournament. The Winnipeg Children's Access Agency was the charity for this year's tournament.

MBA Awards

closer first-hand look at how well-run

One of the main items for discussion at the Board this year has been the finalization and beginning stages of the implementation of the CBA's new strategic plan, *Crystal Clear*. The strategic plan does not represent a dramatic change in the direction of the Association, but rather provides focus to the CBA's activities. In the initial stages a great deal of effort will be spent on maintaining and improving member services and recruitment of new members in order to maintain and enhance the CBA's position as the voice of the legal profession in Canada.

A number of issues were dealt with at the Board over this past year. Presentations were received from the CBA's Conflict of Interest Task Force, which is now in the process of consulting with lawyers regarding the establishment of clearer rules governing conflict of interest in the lawyer-client relationship. The Canadian Judicial Council gave a presentation in which the CBA's support was requested for alternative models of court administration that would give greater control over court resources to the courts themselves. CBA President Parker MacCarthy, Q.C. engaged the Board in taking action on the issues faced by rural practitioners and the difficulties in finding adequate legal services in rural and remote communities. We dealt with the CBA's court interventions including the (unsuccessful) decision in Christie, and heard from the working group on no-fault insurance (still a large issue in some provinces).

I am confident that, through the diligence and strength of the CBA and the efforts of its members, the many challenges now being faced by our profession and those new challenges that loom upon the horizon will be well met and that our membership and our systems of justice will be well-served. I encourage you to get involved; you will find your participation to be valuable and rewarding.

Annual Report 2006-2007

EXECUTIVE DIRECTOR'S REPORT

On June 15, 2005, MBA Council approved a 4 year strategic plan for the Branch and work has been proceeding on meeting the objectives of that plan. On December 7, 2006 the MBA Executive Committee held a brainstorming session and reviewed the work already accomplished in the current strategic plan and discussed possible changes to the plan based on the new CBA 5 year strategic plan approved in 2006/2007. On June 13, 2007 the MBA Council adopted a new 5 year strategic plan.

The Manitoba Bar Association is the Association of lawyers, judges and law students in Manitoba. Our purpose is to advance the interests of our diverse membership and to promote the essential role of the legal profession in our society.

As the voice of the legal profession, the Manitoba Bar Association is a leader in the community, providing high quality training and services, increased involvement in the development of legislation and promoting high standards of professionalism. Representing those who work within the legal profession, the Manitoba Bar Association will be a relevant and proactive advocate for its members and a presence within the legal community.

Over the past five years that I have been the Executive Director of the Manitoba branch of the Canadian Bar Association, many accomplishments have been made. Highlights of these, not already mentioned in the other reports, for 2006/2007 include:

- The MBA moved its offices on September 1, 2006 to 1450-363 Broadway, Winnipeg, MB R3C 3N9.
- Robert Dawson represented the MBA as an intervener at the MPI PUB Rate Application hearing in October 2006.
- A kick off Women Lawyers' Forum reception was held on Tuesday, October 24, 2006. Approximately 81 members attended this event.
- The Ad Hoc Committee of MBA Past-Presidents met on October 31, 2006 to discuss various issues and make a recommendation regarding the Distinguished Service Award recipient.
- Representatives of the MBA met with The Honourable Dave Chomiak on November 9, 2006, January 30, 2007 and June 18, 2007.
- The MBA continues to raise the issue of Legal Aid with the Minister of Justice and Attorney General for Manitoba. The Manitoba Bar Association has two representatives on the Legal Aid Advisory Committee, Sandip Sett and Saul Simmonds. In addition, Antoine Hacault sits on the Advisory Committee. The CBA continues its work on the Legal Aid test case. The National office and each of the branches are providing the financial support for this test case.
- On September 19, 2006 representatives of the MBA met with Hugh McFadyen, Leader of the Official Opposition and Kelvin Goertzen, Justice Critic.
- On November 28, 2006 the provincial government announced The Registered Retirement Savings Protection Act which is designed to protect creditors retirement savings held in deferred profit sharing plans, registered retirement savings plans and registered retirement income funds. The MBA has been lobbying the provincial government for many years on this issue. Although all of our recommendations were not included in the new legislation it is a positive benefit to our members. The legislation is expected to take effect on November 1, 2007.
- The 2007 Mid-Winter which was held on January 25 27, 2007 featured 7 CLEs: Duty to Consult, Managing Clients, Joint Ownership, Defamation Actions, 15 Minute Family Lawyer, 25 Years of the Charter and Raising Capital. The 2007 MBA Distinguished Service Award was presented to Professor Trevor Anderson, Q.C. and the 2007 Pro Bono Award Recipient was Veronica Jackson of the firm Gange Goodman & French. The MBA Council Awards were also presented at the ceremony: Community Involvement Award to Stuart Blake, Fillmore Riley LLP for his work with the Winnipeg Humane

Society; Council Member Awards to Veronica Jackson, Gange Goodman & French, Sandra Phillips, Barrister & Solicitor and Jacqueline St. Hill, Manitoba Justice; Equality Award to Brenlee Carrington-Trepel, Equity Ombudsperson, The Law Society of Manitoba; and, Headnotes & Footnotes Award to Dean Scaletta, Manitoba Public Insurance.

- CBA President, Parker MacCarthy, Q.C., was in Winnipeg on January 27, 2007 for the MBA Mid-Winter meeting. In addition, we were also pleased to have James Morton, Ontario Branch President and Inez Cardinal, Saskatchewan Branch President attend our Mid-Winter and speak to Council.
- Mr. Justice John Scurfield of the Manitoba Court of Queen's Bench was the keynote speaker for the Young Lawyers' Judges lunch which was held on April 19, 2007. Approximately 95 people attended the luncheon that was sponsored by CBIA.
- The MBA, the Office of the Public Trustee and The Winnipeg Foundation presented "Will Week" from April 23 – 27, 2007. The initiative is intended to raise public awareness of the value of estate planning, and stressing the importance of having a will, power of attorney and living will. MBA members generously volunteered their time to present a number of public information sessions during the week in Portage La Prairie, Ste. Rose du Lac, Swan River, Winkler, and Winnipeg. The sessions proved to be well attended (in excess of 1,163 people in Winnipeg) and well received.

It was moderated by Janet Stewart, News Anchor CTV and opening remarks by Jon Singleton, F.C.A, former Manitoba Auditor General. Thanks go to Wayne Forbes, Chair of the MBA Health Law Section and Brian Bowman, Chair of the CBA Privacy & Access Law Section for their work on these events.
- Weekly court decisions were distributed to subscribing firms.

NOTES TO FINANCIAL STATEMENTS

Year Ended August 31, 2007

1. PURPOSE OF THE ORGANIZATION

The Manitoba Bar Association, a branch of the Canadian Bar Association, is a non-profit organization dedicated to enhancing the economic, professional and social interests and well-being of its members throughout the province of Manitoba. The Manitoba Bar Association represents approximately 1,250 members of Manitoba's legal profession, including: lawyers, judges, law students and law professors.

2. SIGNIFICANT ACCOUNTING POLICIES

a) METHOD OF ACCOUNTING

The Association follows the restricted fund method of accounting. Revenue and expenses related to program delivery and administration are reported in the General Fund, on an accrual basis. Purchases, sales and amortization of capital assets are reported in the Capital Fund. Revenue and expenses related to participation in the Canadian Bar Association's annual meetings are reported in the Conference Fund, on an accrual basis.

b) INVESTMENTS

Investments are recorded at cost. Interest income is recognized as revenue when earned.

c) CAPITAL ASSETS

Ćapital assets are stated at costs less accumulated amortization, recorded on the straight-line basis at a rate designated to amortize the cost over the estimated useful life: Computers – 3 years; Furniture and equipment - 5 years.

d) USE OF ESTIMATES

The preparation of financial statements in accordance with Canadian generally accepted accounting principles requires management to make estimates and assumptions that affect the reported amount of assets and liabilities at the date of the financial statements and the reported amount of revenues and expenses during the reporting period. Actual results could differ from these estimates.

e) FAIR VALUE

Due to the short-term nature of all financial instruments other than long-term debt and long-term investments, the carrying values as presented in the financial statements are reasonable estimates of fair value. Management has estimated fair value by reference to established financial markets. As is true for all estimates, actual fair value could differ from this estimate, and if so, any difference would be accounted for in the period in which it becomes known. For long-term investments and long-term debt, it is not practicable within constraints of timeliness or cost to determine the fair value with sufficient reliability because the instruments are not traded in an organized financial market.
