PRESIDENT'S REPORT

My second year as President continued to be both challenging and rewarding. The CBA Re-Think Project, originally launched in 2014, had moved from the conceptual to the real. In August 2016, CBA Council passed a resolution adopting a new governance model. Over the 2016-2017 year, numerous working groups came together and undertook drafting significant changes to the CBA By-Laws. I attended numerous CBA Board meetings (the majority by teleconference) considering the various phases of implementation and new wording that would be required. As you are aware, in August 2016, CBA Council approved a resolution to dissolve itself and pass all of its powers on to the CBA Board. In June 2017, the CBA Board passed a resolution approving the changes to the CBA By-Laws, which included the holding of an Annual General Meeting (AGM). The first CBA AGM was held in August 2017 in Montreal. Not only could members attend in person in Montreal, they could also attend at numerous hubs across the country, including one in Winnipeg. At the AGM, the members voted to approve the By-Law changes reflecting the new CBA governance model. In June the MBA also made some changes to our own By-Laws to reflect some of the changes in governance.

On the CBA Board front, Dean Scaletta was appointed as the board member from Manitoba for a one year term. Dean's knowledge as the former CBA Treasurer (a position eliminated as a result of the governance changes) landed him the position as the chair of the CBA Finance Committee!

Some additional key changes that have occurred are as follows:

- 1) The CBA Board has been reduced from 26 to 14 members;
- CBA Board members will serve two year staggered terms and will no longer include members of branch executives;
- 3) There is now only a President and Vice-President of the CBA;
- There is one board member from each province and territory;
- 5) A matrix to address issues of diversity has been developed and was utilized during the vote for the CBA Board;
- All existing CBA Committees were dissolved and replaced with three Committees – Finance, Governance and Equality and Policy;
- 7) There will be a new CBA Leadership Forum to allow various leaders with the CBA and the various branches to meet and discuss items of concern this will be an annual meeting to be held in conjunction with the AGM;
- 8) A formal management team has been established, which is comprised of senior management in the CBA and the branches/CCCA which meets regularly;
- 9) While each branch will approve its own budget (which the MBA did in June), the CBA budget and all branch budgets will be consolidated for the first time.

I should note that in late 2016, Cheryl Farrow became the new

CBA Chief Executive Officer, replacing John Hoyles who retired. Cheryl has done an excellent job in taking over and starting the hands on job of implementing the new governance and business model. Her experience in "change management" should assist the CBA greatly. I had the pleasure of working with her on the CBA Board.

It has been my pleasure to represent you as President over the last year and I want to thank you for providing me with that opportunity.


VICE-PRESIDENT'S REPORT

MEMBERSHIP/MEMBER SERVICES REPORT

This has been my second and final year as the Director of Membership/Membership Services. It has been a privilege over the course of the two years to work in this capacity. I can only emphasize that our membership is well served with a terrific staff, as well as a very supportive Executive Committee and Council. The Bar Association continues to strive to provide high quality services, and it has been my personal objective to satisfy the trust that has been placed in me as the Director of Membership Services.

Consistent with the previous years, our recruitment efforts are geared toward the future of the legal profession. With that we began the school year at the Faculty of Law with a champagne reception in order to introduce the first-year students to the Bar Association, and to invite them to take out a membership. We also continued to run the MBA mentorship program, which is always highly appreciated by the students. We appreciate our partnership with the MLSA, and particularly appreciate the hard work of our MLSA representative, Maddie Pearlman, in organizing this program.

Our members continue to benefit from the many services and benefits that the MBA provides. Of significant benefit are the Continuing Professional Development programs, primarily provided by our Sections, and our hard-working volunteers that are involved in them. In addition, we also ran another highly successful Mid-Winter Conference. Members continue to receive benefits from our preferred suppliers, by receiving savings on their insurance, cell phone, car rentals, amongst others.

Our strong renewal rate for membership provides us with a sense of validation that our members appreciate the services that are

provided. We do not ever take that for granted. Our total membership continues to be slightly over 1,400 individuals. Our market penetration as well as our overall renewal rate significantly exceeds the national average.

As Director of Membership Services, with the assistance of the entire Executive and MBA staff, we have reached out to lapsed members through personal phone calls, not only to encourage them to renew, but to determine how we can better address their needs or better communicate the services that the MBA already offers. In addition, welcome letters are sent out to all new members that outline the benefits of membership that they can receive.

I have thoroughly enjoyed my tenure as Director of Membership, in order to engage the challenge of addressing the needs and expectations of our members. It is of paramount importance that continued efforts be made to prioritize the needs of our members. I would like to thank everyone for their support and encouragement during these two years, including the MBA Council, my colleagues on the Executive, and especially our Executive Director, Stacy Nagle, and her entire team. Their hard work and dedication has made my job a pleasure to carry out.

EXECUTIVE DIRECTOR'S REPORT

In February 2016, the CBA approved a new strategic plan. The following is a list of the activities undertaken by the MBA in 2016/2017 under the headings of the five strategic pillars included in the CBA strategic plan.

Develop Deep, Smart Member Intelligence

Deepen the knowledge and understanding of Members to better assess their aspirations, needs and satisfaction levels. Smarter data will lead to more relevant communications with Members and leading-edge offerings that equip them for success.

- The MBA Executive Committee members monitor monthly membership statistics.
- The MBA Executive Committee also monitors monthly website usage.
- The MBA participated in a CBA Connexions pilot project that connected newly-joined young lawyers with a peer in Manitoba. Various information was collected from this pilot project regarding why young lawyers join the CBA and what services they are hoping to receive from their membership.

Deliver Distinct & Relevant Professional Development

Deliver professional development (PD) that includes both substantive education and skill development. Substantive education is important and will continue. Skills development offerings will be enhanced. Skill development is broadly defined and will be determined based on member needs, and includes cultural competence and skills and tools for self-improvement and personal success. An increased emphasis will be placed on delivering offerings both in English and French.

- The MBA and The Law Society of Manitoba hosted a luncheon with The Hon. Supreme Court of Canada Justice Richard Wagner on September 14, 2016. The MBA and The Law Society of Manitoba also hosted a luncheon with Supreme Court of Canada Justices, The Hon. Justice Michael Moldaver and The Hon. Justice Suzanne Côté on June 5, 2017.
- The MBA, the University of Manitoba Faculty of Law and The Law Society of Manitoba featured the 2016 Isaac Pitblado Lectures on November 4 – 5, 2016. The conference discussed the Calls to Action from the Truth and Reconciliation Commission.
- The 2017 MBA Mid-Winter Conference was held on January 19

 21, 2017. It featured 16 continuing professional development (CPD) sessions, which provided 39.5 hours of CPD, a bench and bar reception, an exhibitor trade show and the Awards luncheon. Approximately 475 people attended the conference.
- In 2016-2017 a total of 2,993 members attended 79 Section meetings, which provided over 107 hours of continuing professional development, many offered at no charge for members. Where possible, these meetings offer teleconferencing for members outside of Winnipeg. These numbers include five meetings that were held via webinar. Written materials from Section meetings are posted behind the wall on the MBA web-site. Branch Section Chairs attended CBA National Section meetings. Travel rebates are provided to

- members outside of Winnipeg to attend MBA education programs in Winnipeg.
- The MBA promoted other CBA online and Law Society of Manitoba CPD programs.

Advocate on Behalf of the Profession

Focus on issues that shape the legal profession, improve the law, or advance the Rule of Law, including access to

justice, through means such as interventions and influencing the legislative process. Inform and solicit feedback from Members at all levels

- Representatives from the MBA met with the Attorney General and Minister of Justice for Manitoba.
- The MBA Legislation and Law Reform Committee reviews legislation introduced and forwards it to Section representatives for their information and possible comments.
- The MBA Technology, IP & Privacy Law Section submitted comments to the government regarding possible changes to The Personal Health Information Act and The Freedom of Information and Protection of Privacy Act.
- Representatives of the MBA met with the Chiefs and Associate Chief Justices and Judges.
- Representatives from the MBA participated at Legal Aid Advisory Committee meetings.
- Representatives from the MBA met with Dean Jonathan Black-Branch, Robson Hall - Faculty of Law.
- The MBA President, or their representative, spoke at Judicial swearing-in ceremonies.
- The MBA President, or their representative, participated on a Provincial Court Judicial Nominating Selection Committee.
 The MBA also has a representative on the Federal Judicial Advisory Committee.
- Responded to media inquiries.
- An open house for the public was hosted at the Winnipeg Law Courts Building in Winnipeg on April 9, 2017 for Law Day. The open house included: guided tours of the law courts, exhibits and displays, special sitting of citizenship court, mock trials in French and English presented by elementary and senior high students, high school student debates in French, question and answer sessions, and demonstrations by a victim services dog and a drug detection dog and their handlers. Approximately 1,200 people attended the open house. An open house was also held in Brandon on April 9, 2017 that included guided tours of the Court House and legal information sessions. In addition, Morden held an open house on April 28, 2017 that included a mock trial presentation and a question and answer session. Social media outlets Facebook and Twitter were used to promote 2017 Law Day activities, including some paid advertising.

EXECUTIVE DIRECTOR'S REPORT cont'd

- The MBA, the Office of the Public Trustee, and The Winnipeg Foundation presented "Will Week" on April 24 28, 2017 that provided free estate-planning seminars.
- The MBA participates on the Law Society of Manitoba's Forgivable Loan Program Committee and Access to Justice Committee and Sub-Committees.

Prepare the Profession for the Future

Building on a strong Futures foundation, further elevate CBA's leadership thinking to guide the profession toward a future that is in-step with emerging trends, needs and opportunities. See things before others see them, and inspire Members to lean into the future.

- Various Section meeting topics and articles contained in Headnotes & Footnotes focused on preparing the profession for the future.
- The MBA Women Lawyers' Section announced a new program for women lawyers to connect them with women Judges/Justice to obtain information about applying to be on the bench.

Cultivate an Inclusive, Engaged Professional Community

Build a more powerful, inclusive, diverse and engaged professional community across Canada. Prioritize building membership among groups such as law students, articling students and young lawyers. Encourage Member exchange of knowledge, discourse on professional issues and peer-to-peer support. Facilitate interpersonal connections in person and, importantly, online.

- The mentorship program matched 69 law students and lawyers and held two networking events.
- The MBA hosted a reception for new law students during orientation week at the Faculty of Law, spoke to CPLED students during the first week of classes, hosted a reception for CPLED students and spoke at the Call to the Bar ceremony.
- The contributions of the legal profession were recognized through Awards and a "What's Happening" column in *Headnotes & Footnotes*. The MBA also provides a financial prize for the first and second place students in the Robson Hall moot court competition.
- The MBA/RMTC joint production of *Twelve Angry Jurors* was held on May 3 – 6, 2017. To date, CBA members have raised over \$1 million for RMTC.
- · Various networking events were held throughout the year.
- MBA has a membership with Kids & Company Daycare. MBA members are guaranteed a full-time or part-time child care spot within six months.
- The MBA provided funding to a law firm in an underserviced area in Manitoba to hire a summer law student as part of our contribution to The Law Society of Manitoba's Forgivable Loan program.

- Members of the MBA Executive attended regional bar meetings.
- Various membership recruitment and retention activities were held in 2016-2017.
- Weekly decision packages were distributed to subscribers.
- Ten editions of *Headnotes & Footnotes* were prepared and distributed. Some members continue to receive the newsletter via a link to a pdf version or an on-line magazine format on the MBA web-site instead of a paper copy.
- Approximately 875 copies of the 2017 Legal Directory and 875 copies of the Legal Directory and Dayplanner were sold.
- On average <u>www.cba-mb.ca</u> has over 1,000 visitors each month. On December 19, 2016 the MBA launched its new web-site.

Organizational Infrastructure

- Participated on the CBA Management Team who is working on preparing the operational side of the Association's transition within the new CBA governance structure.
- Co-Chaired a team of CBA staff from across the country who looked at how the CBA can develop a coordinated approach for professional development and Sections to enhance service to members.
- Participated on the CBA Committees Transition Team that was responsible for reviewing the existing CBA Committees and recommend which should be disbanded.
- The MBA By-Laws were revised, and Section Regulations were included to address the CBA governance changes.
- A Harassment & Violence Prevention policy, a policy on Section Submissions, Statements & Policies and Guiding Principles for Nominations to the Senate of Canada were approved for the MBA.
- Section Leaders', Council and Executive Committee orientation sessions were held.
- The MBA established a twitter account (@MBBarAssn) on January 26, 2017.
- Thank you letters were sent to MBA volunteers.
- · All MBA staff receive yearly written evaluations.
- Staff is encouraged to take professional development.
- An audit was conducted on October 12, 2017 and no concerns were identified.

Thanks go to the MBA Executive Committee, Council and all the other great volunteers who give so much of their time, knowledge and expertise to support the work of the MBA. Finally, I would also like to thank the MBA staff; Chelsey Tait, Melissa Tannahill and Kara Moore. They make coming to work fun and enjoyable.



ADVOCACY AND PUBLIC RELATIONS

I have now completed my first year of a two-year term in the position of Director of Advocacy and Public Relations. It has been an honour to be part of the Manitoba Bar Association (MBA) Executive, and to be an active participant and observer of the many activities with which the MBA is involved as the voice of the legal profession in Manitoba. The membership itself is presently comprised of approximately 1,400 lawyers, law students, articling students, members of the judiciary and law professors such that the professional and social benefits it provides are vast in scope.

As Director of Advocacy and Public Relations, I have been responsible for activities and initiatives of the Branch relating to advocacy, legislation and law reform and public relations, including promoting communication of these efforts within the Province.

In this role:

- I participated in Access to Justice Initiatives as MBA Representative, including the Access to Justice Steering Committee and Stakeholders Committee. In addition, I provided input on improving public access to research resources and tools during various teleconferences for different access groups.
- I was your MBA Representative on the Lawyer's Play Committee. This year marked the 25th Royal Manitoba Theatre Centre (MTC)/MBA Lawyer's Play, *Twelve Angry Jurors*. It is astonishing to believe that some of the original talented actors and actresses from the same play twenty-five years ago were also in this one! To date, we have raised more than \$1 million dollars for the programs and productions of the Royal MTC due to this wonderful collaborative effort.

 Throughout the year, the MBA's website was frequently visited by its members, the legal community, and the public. The statistics were steady, with an observed growth during the months leading to the January Mid-Winter Conference. In that regard, I was involved in the selection process for the

- Headnotes & Footnotes was published and distributed 10 times this past year. I was

also privileged to participate in a Judicial Nominating Committee chaired by Chief Judge Wiebe, which led to a judicial appointment in Thompson, Manitoba.

It has been my pleasure to represent you as Past President for a second year and I thank you for providing me with that opportunity. I wish to extend my sincere thanks and appreciation to

SECRETARY / TREASURER'S REPORT

Attached are the audited financial statements for the Manitoba Bar Association (MBA) for the fiscal year ended August 31, 2017 prepared by Dean R. Jenkyns of Jenkyns Smith Chartered Accountants LLP. This is the fifth year that the financial statements have been prepared in accordance with Canadian Accounting Standards for Not-for-Profit Organizations, which

the MBA adopted effective September 1, 2012. Several items are worthy of note:

- Several years ago, Council determined that it would be appropriate to reduce the MBA surplus which at that time represented approximately six months of operational funding. To that end in 2016-2017, the Association budgeted for a deficit of \$12,560. Primarily due to growth in membership services revenues and a significant decrease in our expenses especially the Council activity (due to the lack of national meetings), the MBA realized an operating surplus of \$56,603.
- The aggregate of current assets and long term Investments at year-end grew from \$324,567 to \$386,275. Long term

Investments saw a modest increase (from \$118,987 to \$121,486), while the cash on hand at year-end was significantly higher (\$230,214 as compared to \$148,953). Our investments continue to be made up primarily of equity funds with some guaranteed investment certificates. We added capital assets this year as well (new computers and peripherals) which will be amortized over the next few years.

- Our aggregate revenue actually diminished a bit this year from \$627,989 in fiscal year end 2016 to \$620,461, however our expenses dropped from \$590,517 to \$560,030 giving us a substantially better net income as noted above.
- The MBA continues to be fiscally prudent and financially strong, putting it on a solid foundation for the realization of its short and long-term strategic goals. We will continue to monitor our income and expenses as the CBA moves through the Re-Think transformation to ensure that we continue this trend.
- While I am technically responsible for the budget all the credit for the hard work and excellent care should go to our Executive Director, Stacy Nagle and her excellent team.

Independent Auditor's Report to the Members of Manitoba Bar Association

We have audited the accompanying financial statements of Manitoba Bar Association, which comprise the statement of financial position as at August 31, 2017 and the statements of revenues and expenditures, changes in net assets and cash flow for the year then ended, and a summary of significant accounting policies and other explanatory information.

Our responsibility is to express an opinion on these financial statements based on our audit. We conducted our audit in accordance with Canadian generally accepted auditing standards. Those standards require that we comply with ethical requirements and plan and perform the audit to obtain reasonable assurance about whether the financial statements are free from material misstatement.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation and fair presentation of the financial statements in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by management, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.

Opinion

In our opinion, the financial statements present fairly, in all material respects, the financial position of Manitoba Bar Association as at August 31, 2017 and the results of its operations and its cash flow for the year then ended in accordance with Canadian accounting standards for not-for-profit organizations.

NOTES TO FINANCIAL STATEMENTS

Year Ended August 31, 2017

1. PURPOSE OF THE ORGANIZATION

The Manitoba Bar Association, a branch of the Canadian Bar Association, is a non-profit organization dedicated to enhancing the economic, professional and social interests and well-being of its members throughout the province of Manitoba. The Manitoba Bar Association represents approximately 1,400 members of Manitoba's legal profession, including: lawyers, judges, law students and law professors.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

Basis of presentation

The financial statements were prepared in accordance with Canadian accounting standards for not-for-profit organizations (ASNFPO).

Fund Accounting

The Association follows the restricted fund method of accounting. Revenue and expenses related to program delivery and administration are reported in the General Fund, on an accrual basis. Purchases, sales and amortization of capital assets are reported in the Capital Fund.

Capital assets

Capital assets are stated at cost less accumulated amortization. Capital assets are amortized over their estimated useful lives at the following rates and methods:

Computer equipment 3 years straight-line method Furniture and fixtures 5 years straight-line method

The Association regularly reviews its capital assets to eliminate obsolete items.

Investments

Investments are classified as held for trading and are recorded at market value.

Revenue Recognition

Restricted contributions related to general operations are recognized as revenue of the General Fund in the year in which the related expenses are incurred. All other restricted contributions are recognized as revenue of the appropriate restricted fund.

Unrestricted contributions are recognized as revenue of the General Fund in the year received or receivable if the amount to be received can be reasonably assured. Investment income is recognized as revenue of the General Fund when earned.

Fees and other income are recognized as revenue of the General Fund when the events are held and or services or products are provided.

Deferred revenue

Deferred revenue reported in the General Fund relates to revenue collected for the legal directory which will not be issued until the subsequent year.

Measurement uncertainty

The preparation of financial statements in conformity with Canadian accounting standards for not-for-profit organizations requires management to make estimates and assumptions that affect the reported amount of assets and liabilities, disclosure of contingent assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the period. Such estimates are periodically reviewed and any adjustments necessary are reported in earnings in the period in which they become known. Actual results could differ from these estimates.

Financial Instruments

Fair Value - Fair value is the amount that would be agreed upon in an arm's length transaction between knowledgeable willing parties who are under no compulsion to act. Fair value is an estimate, which is significantly affected by the assumptions and methods used in its determination. Further, estimation of fair value involves the use of subjective judgments and uncertainty. Fair value should not be interpreted as an amount which could be realized in immediate settlement of the instruments. With the exception of investments, management has estimated that the fair value of all financial instruments approximate their cost, as there is no active market for the assets and liabilities of the association that are financial instruments. The fair value of investments is based on the quoted market values.

6. FINANCIAL INSTRUMENTS

The association is exposed to various risks through its financial instruments and has a comprehensive risk management framework to monitor, evaluate and manage these risks. The following analysis provides information about the association's risk exposure and concentration as of August 31, 2017.

Credit risk

Credit risk arises from the potential that a counter party will fail to perform its obligations. The association is exposed to credit risk from customers. In order to reduce its credit risk, the association reviews a new customer's credit history before extending credit and conducts regular reviews of its existing customers' credit performance. An allowance for doubtful accounts is established based upon factors surrounding the credit risk of specific accounts, historical trends and other information. The association has a significant number of customers which minimizes concentration of credit risk.

Liquidity rish

Liquidity risk is the risk that an entity will encounter difficulty in meeting obligations associated with financial liabilities. The association is exposed to this risk mainly in respect of its receipt of funds from its customers and other related sources, long-term debt, obligations under capital leases, contributions to the pension plan, and accounts payable.

6. COMMITMENTS

On August 1, 2012 the Association entered into a 84 month lease for its office, terminating on July 31, 2019. Annual Base rent is as follows each rental period August 1 to July 31, \$13,635.00 (2013), \$14,392.50 (2014), \$15,150.00 (2015), \$15,907.50 (2016), \$16,665.00 (2017), \$18,180.00 (2018), and \$18,937.50 (2019) plus common area costs.
